SUBJECT: Debt Settlement Plan #22-02
Timothy Barr for Congress, Inc. (C00779553)

Timothy Barr for Congress, Inc. ("Committee") has submitted a debt settlement plan ("DSP" or "plan") for Commission approval.¹ The DSP discloses that the Committee owes a total of \$81,168.77 to two creditors, one of whom is the candidate. Attachment at 12. We recommend the Commission approve the debt settlement plan because it satisfies the regulatory factors the Commission considers in evaluating such plans.

I. THE COMMISSION SHOULD APPROVE THE COMMITTEE'S DEBT SETTLEMENT PLAN**A. The Debt Settlement Plan Meets the Six Factors Under Section 116.7**

The Commission reviews debt settlement plans to ensure that neither excessive nor prohibited contributions result from the creation and settlement of a committee's debts. Debts Owed by Candidates and Political Committees, 55 Fed. Reg. 26,378 (June 27, 1990). The

Commission considers six factors in evaluating debt settlement plans: (1) information provided by the Committee and its creditors; (2) the amount of each debt that remains unpaid and the length of time each debt has been overdue; (3) the amount and percentage of each debt that would be forgiven under the plan; (4) the total amount of debts and obligations owed by the terminating committee to all creditors, compared to the total amount of cash on hand and other amounts available to pay those debts and obligations; (5) the year-to-date expenditures and receipts of the terminating committee; and (6) whether the total percentage that was or will be repaid on any loans made by the candidate to the terminating committee is comparable to the total percentage that was or will be paid to other creditors. 11 C.F.R. § 116.7(f)(1)-(6).

Application of the Six Factors.

With respect to the first factor, the Committee must submit information that supports the plan. 11 C.F.R. § 116.7(f)(1); *see also* 11 C.F.R. § 116.7(e) (listing required information). The supporting information must include information about the origination and satisfaction of the debt, including 1) the terms of the initial extension of credit, 2) the candidate's or the committee's efforts to satisfy the debts, and 3) the creditor's use of remedies to satisfy the debt. 11 C.F.R. § 116.7(e)(1)(i)-(iii).

The Committee submitted information in support of the DSP. The plan discloses that the Committee owes \$66,168.77 to J. Russell & Associates, LLC, d/b/a War Room Strategies ("War Room Strategies").² War Room Strategies reportedly provided the Committee with digital, mailer, survey, and signage services.³ The Committee informed this Office that the creditor's invoice for these services was due within 30 days. War Room Strategies represents that it gave the Committee additional time to pay and held finance meetings with the Committee to discuss the outstanding debt. Attachment at 6. The plan also discloses that the candidate called potential donors to raise funds in an effort to satisfy the debt. Attachment at 4-5; 11 C.F.R. § 116.7(e)(1)(ii).

War Room Strategies signed the plan on June 28, 2022, affirming that its efforts to collect the debt were similar to other debt collection efforts against nonpolitical debtors, that the terms of its debt settlement with the Committee were comparable to those it makes with other nonpolitical debtors, Attachment at 7; 11 C.F.R. § 116.7(e)(2), and acknowledging that it accepted the Committee's settlement offer of \$1,909.31, Attachment at 7. The Committee's amended DSP dated September 16, 2022, however, proposes a settlement amount totaling its updated cash on hand of \$2,128.06, Attachment at 12. Although the Committee has not submitted a new vendor signature expressly accepting this higher amount, the Committee's representative informed this office that its intention was always to pay the entirety of its

remaining cash on hand to War Room Strategies to settle the debt. We thus conclude that the absence of an additional signature from War Room Strategies should not bar the Committee from paying this creditor \$2,128.06 since this amount does not exceed the Committee's total outstanding debt to War Room Strategies and because the Committee has no other debts and obligations.

With respect to the second and third factors, the debt totaling \$66,168.77 was incurred on May 24, 2022. This debt remains unpaid.⁴ Under the plan the Committee would pay all of its remaining cash on hand, \$2,128.06, to settle its debt with War Room Strategies. The proposed settlement would result in War Room Strategies forgiving \$64,040.71 or approximately 99% of the debt.⁵ 11 C.F.R. § 116.7(f)(2)-(3).

Analysis of the fourth factor shows that the total amount of the Committee's debts of \$81,186.77 exceeds its available cash on hand, which was \$2,128.06 as of September 30, 2022, and that the Committee has no remaining assets to liquidate.

The Committee's ability to pay its debt to War Room Strategies is limited by the funds available to it or funds the Committee may be able to raise. The plan discloses that the Committee attempted to raise additional funds to repay the debt through candidate phone calls to potential donors seeking contributions. Attachment at 13-14. The Committee, however, has reported raising only \$90 since July 1, 2022, the first full reporting period after the candidate lost the May 24, 2022, primary election.⁶ The candidate is currently a member of the Georgia House

Because of these seemingly inconsistent statements, and the Committee's disclosure of cash on hand that appeared to exceed the debt to War Room Strategies, this office spoke with the Committee's representative. The representative explained that the debt to War Room Strategies remains unpaid. Specifically, the representative explained that the Committee's cash on hand as of May 31, 2022, was \$61,594.28 but those funds had already been committed to paying other expenses, including refunds and other services provided by War Room Strategies. *See, e.g.*, Attachment at 63-64; 66; 71; 73-81; 83-86 (reporting, on Committee's July 2022 report, payments made on or after May 31, 2022, for field work, travel, legal fees, and additional services from War Room Strategies). The representative clarified that the Committee now has \$2,128.06 cash on hand, plus whatever funds the candidate could raise, to pay the debt incurred on May 24, 2022, to War Room Strategies.

of Representatives, but his term expires in January 2023; the Committee's representative told this office that the candidate is not seeking reelection. Because the candidate will soon be neither a state nor federal candidate or officeholder, we conclude that he and the committee may have limited ability to raise funds to pay the debt through further fundraising efforts. The Committee has no other funds, beyond the amounts proposed in the plan to pay War Room Strategies. Under such circumstances, it is unlikely the Committee would be able make additional payments.

For the fifth factor, the DSP discloses the Committee's 2022 year-to-date receipts total as \$272,942.62, and its year-to-date disbursements total as \$439,449.33.⁷

The sixth and final factor involves comparing the total percentage of any loans that were or will be repaid to the candidate with the total percentage that was or will be repaid to other creditors. 11 C.F.R. § 116.7(f)(6). As noted above, the candidate has an outstanding loan to the Committee totaling \$15,000. The candidate, however, is forgiving this indebtedness completely. Consequently, there are no issues with respect to the candidate receiving more in the debt settlement plan than other creditors.

B. The Debt Settlement Plan Does Not Result in An Excessive Contribution to The Committee

We conclude that the foregoing factors weigh in favor of approving the debt settlement plan. 11 C.F.R. § 116.7(f). The information the Committee provided demonstrates that the debt owed to War Room Strategies will be settled under the terms of the debt settlement plan, that the creditor agrees to the terms of the settlement, and that there will be no residual funds. Because the requirements for the debt settlement plan have been met, we conclude that the debt settlement with War Room Strategies would not result in an excessive contribution from that creditor to the Committee. *Id.*; see *Debts Owed by Candidates and Political Committees*, 55 Fed. Reg. at 26,378. Accordingly, we recommend that the Commission approve the debt settlement plan.

II. RECOMMENDATIONS

1. Approve the debt settlement plan filed by Timothy Barr for Congress, Inc.;
2. Approve the appropriate letter; and
3. Close the file.
